Child benefit is undergoing a thorough reform in Belgium. Each region will apply its own child benefit system from **1 January 2019 onwards.**

Each region will offer several payments: an initial amount at birth, a basic monthly amount and possible social supplements. Children who require extra support can still rely on additional allowances. **Families will also be able to choose themselves which child benefit fund they wish to receive their child benefit from.**



As a **parent**, you always want what is best for your child. However, there are undoubtedly a lot of questions you don't have an immediate answer to.

What rights and duties do you have as a parent? Is all your paperwork in order? Will you receive all the allowances to which you are entitled? How will your child really get all the opportunities that are out there?
