

Do you have a child who is in kindergarten?
With the Growth Package, Parentia gives you a financial boost.

What is a kindergarten supplement?

The kindergarten supplement is a supplement for each child that attends a nursery school recognised by the Flanders community.

- A toddler of the age of three has to be registered on time
- A toddler of the age of four has to be registered and has to have a sufficient attendance record

You will receive the kindergarten supplement:

- For children aged three years old: at the earliest in the month following the third birthday of your toddler
- For children aged four years old: at the earliest in the month following the fourth birthday of your toddler

What do you have to do?

- If you are already receiving a Growth Package, you don't have to do anything. The nursery school will inform us of the registration and the days attended of your child. The kindergarten supplement will automatically be paid as soon as you're entitled.
- If you do not yet receive a Growth Package because you don't live in Flanders but your child does attend a nursery school recognised by the Flanders community? Then be sure to return us this application completely filled out and signed via vlaanderen@parentia.be.
You prefer to send the form by post? Then send your application form to P.O.Box 80030 in 1070 Anderlecht.

Please also inform us if your child did not attend kindergarten regularly and if your child should no longer attend a nursery school recognized by the Flemish community.
